Go online to tsa.gov. Complete the online application by entering basic contact information

- Schedule an In-person appointment. You can either make the appointment online or walk into an application center to apply in person. You must schedule your appointment within 45 days of completing the online application.
- Visit a TSA Pre√\* application center to:
  - Provide required documentation and fingerprints. A list of required documents can be found at tsa.gov.
  - Pay a non-refundable \$85 fee valid for five years.

#### After You're Approved

- You will receive a Known Traveler Number (KTN) via U.S. mail within two to three weeks. The number is valid for five years.
- Enter your KTN each time you make airline reservations and begin enjoying your benefits!





### Logo Usage

TSA Pre $\sqrt{2}$  is a Transportation Security Administration (TSA) trademark registered with the United States Patent and Trademark Office (Registration No.: 4559587). The trademark consists of the written words "TSA" and "Pre" with a graphic check mark image directly adjoining the word "Pre". The trademark may not be written as "TSA Pre." In certain media where the graphic check mark symbol *cannot* be replicated, the word "check" may be written in lieu of the as " $\checkmark$ " symbol. Additionally, the trademark may not be identified as "Pre $\checkmark$ " or by the word "Precheck" without including the letters "TSA" as a prefix.

### Fonts

All fonts, including the registration mark (R) are Clan OT News.

### Clearspace and Minimum Size

Appropriate clearing and leading must be taken into consideration for hanging letters and for the check mark symbol. The registration mark (R) should have space before the next character. To ensure the prominence and legibility of the TSA Pre 🗸 logo, always surround it with a minimum amount of clear space. The clearspace for the logo is equal to the height of the uppercase letter "T" in the word "TSA" in the size at which the signature is reproduced.

### Primary Color Palette

All text including the registration mark (R), should be either Department of Homeland Security (DHS) Blue, or White. In instances where the  $\sqrt{}^{\circ}$  (check mark) is used, the color is permitted is DHS Green, unless it is in text copy where all text is black. See below. TT: 1 .....
