Airport authorities have environmental reserves to deal with legacy environmental issues. Contaminants may include fuel before or after combustion, solvents, deicing fluids, landfills or berms which may hold hazardous materials from various FBO activities. Add fire training pits to the list of potential areas of concern. Authorities may have a silver bullet in their old general liability insurance policies (GL) which can be used to offset costs of assessment, characterization, remediation and related legal fees. Nearly all airports purchased GL coverage. You can find and reconstruct your old insurance asset including any applicable predecessor coverage, value it and develop a claim on your behalf to minimize your reserves and eliminate

your legacy environmental issues.
