The firm selected will provide Airport Pavement Management Program Services for the Clark County airport system through County Fiscal Year 2026. Work will be authorized through task authorizations and will be dependent upon availability of Airport Improvement Program funding. The updates will include McCarran, North Las

- An approach to the work that will achieve DOA's stated objectives.
- Commitment of key project personnel to continuity of participation.

Clark County's intention is to evaluate the submissions and subsequently to invite a short list of the highest ranked submissions for oral presentations and interviews from which a Consultant for the Professional Consulting Services for the Airport Pavement Management Program will be recommended for selection to the Board of County Commissioners. No proposed dates for the announcement of the short listed firms and the selection of the recommended Consultant are determined at this time.
