All design and costs are to include Engineer evaluation of required utility improvements, control panels and demolition of existing BHS within ICS rights-of-way and to-be-decommissioned BHS systems. Annual cost estimates of Operations and Maintenance (O&M) for the entire BHS ICS must be included, which includes annual cost estimates for Add Alternate 1 and Add Alternate 2.
