**DESCRIPTION:** The Wayne County Airport Authority (Airport Authority) is soliciting bids from general contractors, construction managers and other businesses that meet the qualifications set forth herein for the McNamara Parking Deck Interior Rehabilitation Project. The project includes structural concrete repairs, drainage system repairs/replacement, waterproofing membrane installation, joint sealant repairs, pavement markings, and general parking deck maintenance on levels 2 and 3 of the McNamara parking structure. The project also includes flashing installation at the top of the "D" stairs to limit water infiltration. The contract scope of work awarded with this solicitation is intended to be completed during the construction seasons of 2024 –2026. **(The Contract resulting from this solicitation is subject to Airport Authority Prevailing Wages Requirements.)**
