DESCRIPTION: Bids are being solicited for purpose of contracting for as needed replacement and corrective and preventative maintenance for designated automatic, sliding, rotating, and folding doors for the Wayne County Airport Authority (Airport Authority) on an as-needed basis. The contract will be for a term of three years, with two (2), one-year renewals exercisable by the CEO.
