Pursuant to the provisions of KRS 424.260, the Kenton County Airport Board (“KCAB” or “Owner”) will receive competitive sealed proposals for **Electric Vehicle (EV) Charging Station Hardware** at the Cincinnati/Northern Kentucky International Airport (“Owner”) located in Boone County, Kentucky (the “Project”). Proposals will be received no later than **February 20, 2025, at 2:00 p.m. ET**. No proposal will be accepted after that time unless such date or time is extended pursuant to an addendum issued by KCAB.

A pre-proposal meeting will be held on January 30, 2025, at 1:00 p.m. ET at the CVG Centre, Admin. Offices, 77 Comair Blvd., Erlanger, KY 41018.
