OCIP on a Diet: A Deeper Dive into General Liability-Only Programs for Airport Construction Projects (1.5 CPE Credits)

Consolidated insurance programs have been a very popular way to finance construction risk for large airport

projects. Specifically, OCIPs and CCIPs have dominated the conversation for years. Another option available to airports is to sponsor a general liability-only program. These programs provide the airport owner with catastrophic protection, control over coverage, and a single policy covering all contractors performing work on site. One distinct advantage over a dual-line OCIP is that their administrative burden is much lighter. They do not come with the high administrative burden associated with consolidating workers' compensation risks.

This session will take a deeper dive into general liability-only programs and their advantages over the traditional OCIP and CCIP models. Risk managers from airports will participate on the panel to speak about their programs and how they have functioned. In addition, specific implementation and program design best practices will be shared with session participants.
