2.3 **Proposer's Minimum Requirements:**

A. **Experience:** The Proposer must have the following experience:

- 1. In the area of airport program management and strategic advising/leadership.
- **2.** Overseeing a minimum of three airport large capital programs with a minimum contract value of \$75 million each.
- **3.** Expertise with a variety of delivery methods, understand the sources and uses of available funds, and have demonstrated experience developing complex financial strategies and models for complex airport projects.
- **4.** The ability to establish an office in Palm Springs and at a minimum the project managers should reside in or near Palm Springs in order to be available and responsive to the airport for the term of the agreement.
- **5.** Possession of Program Management Professional (PGMP) or Project Management Professional (PMP) Certifications is highly desirable.

B. Knowledge:

- **1.** The Proposer must have an understanding of the unique issues facing the development of small-hub or medium-hub airports.
- **2.** The Proposers submitting a Statement of Qualifications & Experience (SOQ&E) should, at a minimum, possess demonstratable skills, detailed knowledge, and applied experience in the following areas:
 - **a.** Knowledge of and experience in project scheduling, design of architectural and civil projects, project controls, and grant administration.
 - **b.** Knowledge of FAA Advisory Circulars pertaining to design, constructions, project management, reports, and correspondence with FAA.
 - **c.** Experience with similar contracts providing consulting services under FAA Advisory Circular AC 150/5100-14 (current revision).
 - **d.** Familiarity with FAA processes and procedures relating to project development, grant applications, and use of FAA documents in preparation of plans and specifications, project status reports.

C. Minimum Key Personnel Requirements:

- 1. Each key staff members assembled on the proposed team shall have at least 10 years of demonstrated experience in any/all of the areas indicated: scheduling, design of architectural or civil projects, project controls, and/or contract management.
- 2. The Proposers shall identify and provide a detailed resume for the propose project manager for this assignment, including full work history, special qualifications and demonstrated experience. Experience working at a commercial airport in an operational public environment on multi-phase construction projects is required.
- 3. The Proposers shall identify all key personnel assigned to work on the assignment through the life of the program. Recommended key staff include Project Manager, Scheduler, Controls Manager, Change Control Manager, and Design Manager. The Proposers will be required to obtain PSP approval for key personnel changes from the PSP executive team throughout the life of the contract and newly assigned key personnel will be required to meet the above requirements.
- D. Business License: The selected firm will be required to be licensed in accordance with the City of Palm Springs Business License Ordinance, Municipal Code Chapter 3.40 through 3.96, entitled "Business Tax". Proposers may obtain the license after award but must do so promptly as the license will be routed with the contract for final signature.
