The Kenton County Airport Board (“KCAB”) will receive proposals for CVG Global Logistics Park - Enabling Work Design Services at the Cincinnati/Northern Kentucky Int’l Airport (“CVG”). Proposals must be received by Thursday, July 3, 2025 at 2:00 pm. No proposals will be accepted after that time unless such date or time is extended pursuant to an addendum issued by KCAB.

A pre-proposal meeting and site visit will be held on Thursday, June 5, 2025 at 10:00 am at CVG Centre, 77 Comair Blvd., Erlanger, KY 41018.
